BPPI was established in December 2008 under the Department of Pharmaceuticals, Government of India, with the support of all the CPSUs, and identified as the executing agency for PMBJP.

The Bureau has been registered as an independent society under the Societies Registration Act, 1860, in April 2010. BPPI follows the provisions of GFR 2017 as amended from time to time, the CVC guidelines, and instructions from the Department of Pharmaceuticals.

3. Copy of FSSAI/WHO-GMP/ISO or any other certificate which certifies quality of product.
4. Copies of audited balance sheet of last three years/ CA certificate certifying annual turnover & financial status
5. Copies of PAN and latest ITR.
6. GST Registration and copy of latest GST return file.
7. In case of imported product, documents like permission / authorization given by the country of manufacturers.
8. Details of product offered giving complete specification.
9. Interested manufacturer/Importer are requested to attend the meeting on 20.11.2018 at 11.00 A.M. in BPPI, 8th Floor, Videocon Tower, Block-E1, Jhandewalan, Extension, New Delhi-110055.
